The FLO International Business, Trade & Start-up Delegation initiative, under the leadership of National President FLO, aims to amplify, develop new business relationships and navigate foreign markets.

The defining purpose of the delegation is to help create economic opportunities to increase trade, business co-operation and investment for Women-owned Businesses. FLO will strive to provide a platform for business introductions and meetings designed to facilitate new market entry, and support international trade and overseas expansion.

FLO will work alongside the Ministry of External Affairs, Women and Child Development, Commerce and Industry etc., and Indian embassies abroad, including counterpart Chambers of Commerce, Govt. and multilateral agencies. Meetings with Heads of State, decision-makers and business delegations will be coordinated to develop meaningful and mutually beneficial partnerships to exchange business ideas, investments, funding opportunities, technology transfer, bilateral business opportunities, and relationships.

OUTBOUND DELEGATION: FLO will visit 3 countries - Japan, UAE and Vietnam - with specific industry interests. They are identified based on the country's expertise, import and export behaviour pattern.

INBOUND DELEGATION: A FLO International Business Summit & Trade Fair to be held in India is also being scheduled (3rd week of January 2024) to further encourage business interactions with global women entrepreneurs. This marquee event is poised to be a springboard for Women-owned Businesses to showcase their capabilities, products and services in various Industry Sectors, including Start-ups. The 1-day Conference, and a parallel 2 days of Expo & Trade Fair with International participation, will create larger opportunity for collaborations and business expansion. The Event will bring in International delegations from various countries, keen on exploring business opportunities and tie-ups with Indian counterparts, which is expected to bring substantial investment into the country.

- Applicants must be in Business for a minimum of 4 years (2 years for Start-ups)
- Must be a registered company of India
- Must be a majority shareholder in the company
- Must be proficient in her business knowledge
- Must have a specific plan for the outcome from the Delegation
- Must be willing to pay for all expenses
- Must be willing to become a member in case of a Non-Member

A pre-departure Seminar will be conducted by FLO to introduce the country of visit's expectations, Govt. policies, tie-up guidelines etc.
